From Ramona Leber at Commerce:

2010-2011: We previously told you that you would be taking a 6.287% across the board reduction to your state funded contract amount for this contract year and that you would receive a letter from Commerce indicating that an administrative amendment had been done. We also told you that it is Commerce's intention to backfill the state reduction with federal carryover funds in a separate and later step.

That process has now changed. The state budget reduction and the federal backfill steps are being done together as a fund switch and you will not receive a letter. **The net effect of these changes to your contract for 2010-2011 is NO reduction.**

2011-2013: As the first step in preparation for the next biennium's budget process, Commerce was asked to propose an additional state general fund budget reduction. After looking at all Commerce programs, the proposed budget put forth by the agency for CM is a 6.8% reduction (.513% more than the 10-11 fiscal year). We wanted to give you this information as soon as possible. Would be loss of \$868. Meth funding (federal funds) not affected.

From Family Policy Council:

Same message of 6.287 percent cut, but don't know what it will look like yet... Potential loss of \$2085 for 2010-2011. 2011-2013 is unknown.
